Commercial Interests Petition FCC for High Power Allocation on Shortwave Spectrum

The ad hoc group "Shortwave Modernization Coalition" petitioned the Federal Communications Commission (FCC) to allow data communications on multiple bands within the HF 2 – 25 MHz range with up to 20 KW, including in bands immediately adjacent to spectrum allocated to the Amateur Radio Service. This group appears to represent high-speed stock trading interests. The FCC has assigned it RM-11953. Comments are due by July 31, 2023, and reply comments by August 15. While the petitioners exclude the amateur bands, high power operations on immediately adjacent bands are proposed. ARRL The National Association for Amateur Radio® is reviewing the petition. Michigan hams exempt from "distracted driving" law

Here in Michigan, Governor Gretchen Whitmer recently signed into law a bill making it illegal to manually use a cell phone or other mobile electronic device while operating a vehicle on Michigan roads. Under the law, which went into effect July 1, a driver cannot hold or support a phone or other device with any part of their hands, arms, or shoulders.

Here's the most pertinent part of the law:

Sec. 602b.

- (1) Except as otherwise provided in this section, an individual shall not hold or use a mobile electronic device while operating a motor vehicle. This subsection does not apply to an individual operating a commercial motor vehicle or a school bus.
- (2) Except as otherwise provided in this section, an individual shall not hold or use a mobile electronic device while operating a commercial motor vehicle or a school bus. As used in this subsection, "use a mobile electronic device" means 1 or more of the following:
- (a) Using a mobile electronic device to do any task, including, but not limited to, any of the following:
- (i) Send or receive a telephone call.
- (ii) Send, receive, or read a text message.
- (iii) View, record, or transmit a video.
- (iv) Access, read, or post to a social networking site.

Fortunately, our ARRL volunteers were able to make sure that lawmakers exempted radio amateurs from this restriction. The exemption reads:

"Mobile electronic device" means an electronic device that is not

permanently installed in a motor vehicle, including, but not limited to, a device capable of text messaging, voice communication, entertainment, navigation, accessing the internet, or producing email. Mobile electronic device does not include either of the following:

- (i) A radio designed for the Citizens Band Service or the Amateur Radio Service of the Federal Communications Commission or a commercial 2-way radio communications device or equipment permanently installed in a motor vehicle.
- (ii) A medical device that is designed to be worn, including, but not limited to, an insulin pump.

The Michigan Section recommends printing out the bill and carrying it with you in the car in case you are stopped by law enforcement and told you cannot operate a radio in your vehicle. While the Michigan State Police seem to understand the law, some of the smaller police departments may not be aware that amateur radio operators are exempt.

Techs: Now is the Time to Upgrade to General!

A new question pool took effect on July 1, 2023, for General-class license exams. ARRL has released new editions of its popular study resources including the 10th edition of The ARRL General Class License Manual and the 7th edition of ARRL's General Q&A.

ARRL has also updated its free online review and practice resource, ARRL Exam Review for Ham Radio.

"ARRL Volunteer Examiners (VEs) are already administering the new General-class exams," said ARRL VEC Manager Maria Somma, AB1FM. Somma suggests that candidates first take a practice test using ARRL Exam Review. "If you're already passing online practice exams, then you're ready to search for an in-person exam session team, or you can take the exam online via a remote video-supervised session." Visit the exam session search page on the ARRL website.

The new General-class question pool is valid for examinations taken between July 1, 2023, and June 30, 2027. "Upgrading from a Technician-class license to General-class significantly opens more operating privileges on HF bands," added Somma.

Treasurer's report: Current account balance is \$4100. We got our check back from Ft. Custer as we won't be there for Field Day. Made a donation of \$150 to the Calhoun Co Fairgrounds for use of their location for Field Day. A motion made to accept, motion passed.

COMMITTEE REPORTS:

- Hamfest No new updates
- Skywarn Per Bret KD8RHB, there was a CERT meeting last night (about 17 attendees). Next Skywarn meeting is Tuesday. There were two failures at the last siren test: Springfield was a new installation (Ave A and Dickman), not sure why it failed; Urbandale also failed. There will be a Fire Station Simulated Emergency Test this Saturday, about 17 locations being covered. Will do a simplex test 146.440 MHz from the fire station locations in Calhoun County, Bellevue, and Olivet, from 10 AM-noon. The State Auxcomm Emergency Test was held on June 3rd, 16 counties participated and CERT was deployed. The Communications truck was stationed at the Haven of Rest shelter for relavs. Placed 8th this year amongst all participating counties. CERT will be assisting at the air show on Saturday and Sunday. They will also be at the Calhoun County Fair. Skywarn will set up for Field Day at the American Legion.
- Field Day Had a last-minute change due to a disagreement between the Michigan DNR and our insurance carrier. Location this year will be the Calhoun County Fairgrounds. Many thanks to Fairgrounds Manager Cathy Combs for allowing us to use their facilities! There is no entry fee for people to come for Field Day. Bathrooms and air conditioning are available. Gate will not be shut. We can use a generator. No picnic tables – we'll need to bring our own tables, chairs, canopies. Camping on the site will also be available. Dan, Tom W. and Kyle will be pulling trailers to the fairgrounds. Melanie will be taking care of the food for lunch on Saturday. Menu items include pulled pork, chicken salad, pasta salad, potato salad, coleslaw, and beverages. Melanie requested someone bring some ice for her to put into a kiddie pool to keep salads cold. - asked what the future will be for SMARS to use Ft Custer. Zach clarified that the issue wasn't with Ft. Custer but with the Michigan Department of Natural Resources and their legal team. Mike KQ8N and Paul KE8MOI stated that we'll likely use the fairgrounds next year for Field Day. Smokey asked what publicity we have out about our Field Day. Bret confirmed WWMT has been notified.
- VE Session Next VE Session is Thursday at 7 PM at Maple United Methodist Church.
- Repeaters Echolink is working. The change that Terry made to the DStar 2m repeater appears to have solved the issues it was experiencing

- POTA Zach W8MAN reported that the club is now up to 134 QSO's from Ft. Custer. Two good spots toward the beach at the picnic tables and the shelter at Whitford Lake. Everyone is invited to participate in the POTA. When you CQ, you only CQ with the club W8DF callsign.
- DX Competition Zach W8MAN reminded participants to submit proof of their contact (QSL card, LOTW log entry, QRZ log entry). Larry KE8TVO had 2 contacts for this month: Korea and South Africa. (Way to go, Larry!)
